RECOMMENDATION

That the Cabinet Member for Finance and the Cabinet Member for Property and Infrastructure agree to the following capital release request of £27k from the Property Works Programme (PWP) Capital Budget 2020/2021; Structural Works Programme – Refurbishment of Manor Farm Great Barn Roof Timbers (Appendix A).

Reasons for recommendation

A specialist team of consultants experienced in historic timber structures has recommended these works are undertaken following a detailed survey March 2020 at the Manor Farm Great Barn.

SUPPORTING INFORMATION

- The Medieval Barn is of historic interest and part of an iconic complex.
- 2. A detailed survey was undertaken after an Arcade Brace came loose in March 2020.
- 3. The survey included an overall structural summary report, a condition report from a specialist structural engineer and Microdrill Assessment report for Death Watch Beetle activity.
- 4. The reports concluded that Death Watch Beetle activity had been present in 7 Arcade Brace Joints and, therefore, they needed to be made structurally sound.
- 5. Further activity and defects were noticed during the survey, but they are of a lower priority and will be surveyed in detail during these works and a report produced.
- 6. The works are proposed to be undertaken by McCurdy & Co Ltd, under a single tender action. McCurdy & Co Ltd are specialist in the field and who replaced the Arcade Brace in March 2020.
- 7. The works will include detail drawings for future reference and meet any requirements from English Heritage.

Financial Implications

Property Works Programme Budget £3,227k, Previously Released/Pending Release £2,124k, Capital Release Requested £27k – Appendix A

The 2020/21 capital programme, approved by Cabinet and Council in February 2020, included a budget for the Property Works Programme (PWP) of £2,878k. Cabinet, in June 2020, approved the re-phasing of £349k of the unspent 2019/20 budget into 2020/21, to give a revised budget of £3,227k, funded from Council resources.

Previously, £2,124k has been released or is included in a release report in preparation (up to Release No 26) from the revised Property Works Programme 2020/21 capital budget.

This report is seeking the release of £27k for the refurbishment of 7 Arcade Brace Timbers and further investigations in the Great Barn, Manor Farm. The release request is based upon the proposed contractor's quoted costs and includes a project contingency of 10% of the quoted costs and internal project management fees of 4.4% of the quoted costs.

The remaining £1,076k of the PWP 2020/21 budget will be allocated to projects as and when required, subject to the capital release procedure.

The knowledge that the Council is taking steps to ensure the iconic assets on the Manor Farm Complex are being maintained ensures residents can continue to make use of and enjoy this important building.

CORPORATE CONSIDERATIONS

Corporate Finance

Corporate Finance has reviewed this report and concurs with the financial implications set out above, noting that the recommended action to agree a release of £27k for the refurbishment of 7 Arcade Brace Timbers and further investigations in the Great Barn, Manor Farm will be funded from the 2020/21 approved Property Works Programme capital budget.

Legal

The Borough Solicitor confirms that the Council is responsible for carrying out this function pursuant to Section 2 of the Occupiers Liability Act 1957. Thus, there are no legal impediments to the capital release being authorised, although any contract that is entered into must comply with the Council's Procurement and Contract Standing Orders.

Infrastructure / Asset Management

Asset Management officers authored the report.

Capital Release Protocol

The release of all capital funds, and certain revenue funds, held by the Council is to be made by a formal democratic decision. No expenditure can be placed or committed by officers until this formal approval is given by Democratic Services. Release of funds must be for identified projects only and strictly not for the general release of funds for projects to be identified at a later date. No block releases of capital or funding will be allowed, except if authorised by the Leader of the Council in advance to Corporate Finance. The release of funds will only be made if previous Council, Cabinet or Cabinet Member agreement has been given to the project and only if there is an approved budget.
