SUPPORTING INFORMATION

Reasons for Recommendation

The Local Authority School Governance Team within the Education Improvement and Partnerships Service has worked with Oak Wood School to transition the current Interim Executive Board into a new Full Governing Body.

The Interim Executive Board was formed in March 2018 and following good improvement, the school is now in a stable position to be governed by a Full Governing Body.



A new Instrument of Governance has been produced with the Interim Executive Board members and agreed on 24th November 2020. This is now ready for approval by the Council.

Associated document – Interim Executive Board Minutes (page 2 in the middle) confirming that the Board has no objections to the new Governing Body transition plan.
