DECISION: FULL APPROVAL

That the Cabinet Member for Finance and Cabinet Member for Property & Infrastructure agreed to the capital release request of £333k for the gas servicing and repairs to Council housing properties from the HRA 2020/21 Planned Maintenance Gas Servicing budget (Appendix A of the report).

Reasons for recommendation

The recommendation will enable boiler servicing and maintenance works to continue to be undertaken in line with regulatory requirements and in response to reported and verified faults.

None. This work will be carried out via a compliant, current, and approved contractor which is still in date to undertake this statutory work function.
