#### **Financial Summary**

To approve the draw-down of capital funds for previously agreed capital programme decisions. This report seeks the release of £312k from the 2020/21 Disabled Facilities Grant Budget for a contingency to draw from for adaptations for non-Council owned properties and Hospital Discharge Grants (HDG). This is broken down by £300k for DFG adaptations and £12k for HDG. The works will commence following the release of funds and expenditure approval as and when required.
