The Leader of the Council and the Cabinet Member for Finance have made the following decision today:

<p>1.</p>	<p><b>THE LEADER OF THE COUNCIL AND THE CABINET MEMBER FOR FINANCE</b></p> <p><b>NEW ALLOCATION OF S106 CONTRIBUTIONS 2020/21: VENUE DOOR SECURITY AND COMPLIANCE TRAINING TO ENABLE OUT OF WORK BOROUGH RESIDENTS TO GAIN EMPLOYMENT WITHIN THE HOSPITALITY &amp; LEISURE INDUSTRY</b></p> <p><b>DECISION:</b></p> <p>That the Leader and the Cabinet Member for Finance agreed that a sum of £53,800 from the S106 contributions held at PPR137/409C, PPR124/398A, PPR142/419C and PPR149/433A is allocated towards the provision of a venue door security and compliance training employment scheme as proposed by Uxbridge College (HCUC).</p> <p><b>REASONS FOR THE DECISION MADE</b></p> <p>Following a Cabinet decision in March 2009, the allocation of Section 106 (S106) and Section 278 (S278) funds is required to be formally approved by the Leader of the Council and the Cabinet Member on a case-by-case basis. This report requests the approval for the S106 funds held at the case reference detailed in this report to be committed as outlined in this report.</p> <p><b>ALTERNATIVES CONSIDERED AND REJECTED</b></p> <p>The Cabinet Members may agree to fund the scheme and / or suggest alternative projects to which funds could be allocated within the terms of the relevant legal agreements.
