DECISION: FULL APPROVAL

1. That the Leader of the Council and the Cabinet Member for Finance approved the allocation of £30k from the S106 contribution held at E/146/450A relating to development at Uxbridge College, Park Road, Uxbridge towards wetland creation and ecological improvements at Hillingdon House Farm; and

2. That the Cabinet Member for Environment, Housing and Regeneration and the Cabinet Member for Finance approved the capital release request of a £70k budget comprising £30k from the S106 contribution held at E/146/450A and £40k GLA grant towards the creation of wetland and ecological improvements at Hillingdon House Farm as set out in Appendix A of the associated report.

REASONS FOR THE DECISIONS MADE

The allocation of Section 106 (S106) and Section 278 (S278) funds is required to be formally approved by the Leader of the Council and the Cabinet Member for Finance on a case-by-case basis. This report requests the approval for the S106 funds held at the case reference detailed in this report to be committed, as outlined in this report.


ALTERNATIVES CONSIDERED AND REJECTED
