DECISION	That the Cabinet Member for Finance and the Cabinet Member for Property and Infrastructure agreed to the capital release request of £1,320k from the Housing Revenue Account Major Adaptations to Property 2021/22 programme budget.
Reason for decision	The adaptations will minimise the possibility of hospitalisation resulting in costs to the health service and social care from falls and other accidents. This is consistent with the policy of prevention and support to enable individuals to live safely in their own homes, the alternative being a long-term residential placement.
