DECISION	That the Cabinet Member for Finance and the Cabinet Member for Property and Infrastructure agree to the following capital release request of £23k from the Property Works Programme 2021/22 Capital Budget for the Replacement supported aids, beds, baths and hoists across the Borough.
Reason for decision	Following an audit of equipment in the residential care homes in the Borough, it has been identified that much of the equipment is either obsolete or near end of life. A planned programme has been put in place to replace obsolete equipment in 2020/21, 2021/22, 2022/23 to keep them operating in compliance with the Lifting Operations and Lifting Equipment Regulations (LOLER) and for residents' and staff health and safety.
Alternative options considered and rejected	The servicing of the equipment is operating in parallel, and only when equipment is beyond repair, will capital replacement/refurbishment be considered.
