DECISION	That the Leader of the Council, the Cabinet Member for Property and Infrastructure and the Cabinet Member for Environment, Housing & Regeneration accepted the single action tender from Pollard Thomas Edwards LLP for the provision of design consultancy services for the development and progression of housing regeneration projects at a cost of £180,344.
Reason for decision	The appointment of external consultants was required to support the delivery of a Council-led housing regeneration project within Hayes (Austin Road and Avondale Estates), which will include the provision of much needed affordable and social housing, as well as the associated infrastructure required to support the proposed developments.
Alternative options considered and rejected	No alternatives to this appointment were considered due to the complex nature of the regeneration projects; it was deemed necessary to continue the approach of appointing external consultancies with appropriate experience and expertise.
