DECISION	APPROVED That the Cabinet Members for Finance, and Property and Infrastructure: <ol style="list-style-type: none">1. accept the tender and approve the award of contract for Phase 13 electrical fire safety upgrades within 274 of the Council's general needs housing stock to PFL Electrical Services Ltd at a cost of £207,246.38; and2. agree to the capital release requests of £238k from the Fire Safety Workstream within the Housing Revenue Account Works to Stock Programme 2021/22 capital budget for the installation of Phase 13 electrical fire safety upgrade within 274 of the Council's general needs housing stock.
Reason for decision	Recent changes to BS5839-6:2019 now require general needs rented housing properties to have a minimum level of LD2 Fire

	<p>Detection, which requires interlinked detection devices to be fitted in all kitchens, principal habitable rooms and escape routes.</p> <p>In order to ensure the electrical installations are in a satisfactory condition to ensure compliance with BS7671, officers have implemented a planned upgrade of electrical consumer units with all general needs housing stock.</p>
