DECISION	APPROVED That the Cabinet Member for Finance and the Cabinet Member for Property and Infrastructure: <ol style="list-style-type: none">1) Accepted the tender and approved the award of contract for Phase 14 electrical fire safety upgrades within 367 of the Council's general needs housing stock to Re-Gen (M&E Services) Ltd at a cost of £271,286.63; and2) Agreed to the capital release requests of £312k from the Fire Safety Workstream within the Housing Revenue Account Works to Stock Programme 2021/22 capital budget for the installation of Phase 14 electrical fire safety upgrade within 367 of the Council's general needs housing stock.

	<p>Detection, which requires interlinked detection devices to be fitted in all kitchens, principal habitable rooms and escape routes.</p> <p>In order to ensure the electrical installations are in a satisfactory condition to ensure compliance with BS7671, officers have implemented a planned upgrade of electrical consumer units with all general needs housing stock.</p>
