DECISION	APPROVED That the: <ol style="list-style-type: none">1) Cabinet Member for Environment, Housing & Regeneration approved the allocation from the Chrysalis 2021/22 programme for the projects as set out in the report;2) Cabinet Member for Environment, Housing & Regeneration and Cabinet Member for Finance accepted the tender from Wicksteed Leisure Limited for the provision of two playground refurbishments to the London Borough of

	<p>Hillingdon for completion by 31 March 2022 and at the value of £180k and;</p> <p>3) Cabinet Member for Environment, Housing & Regeneration and Cabinet Member for Finance agreed to the capital release request of £275k to fund three playground refurbishment projects as detailed within the body of the report, as part of the Asset Enhancement Programme for 2021/22.</p>
Reason for decision	<p>In February 2021 the Cabinet Member for Environment, Housing and Regeneration reviewed all applications for Chrysalis funding received from residents, community groups and Ward Councillors and informally agreed 21 new projects to greatly improve community assets and resources across the Borough.</p> <p>The decision made will enable works to commence on three new playground refurbishment projects based on recently tendered costs.</p>
Alternative options considered and rejected	<p>The Cabinet Members could have decided not to approve the allocations for the Chrysalis programme and either some, or none of the recommended three playground refurbishment projects would not have realised the improvements which have been requested by residents and Ward Councillors.</p>
