DECISION	APPROVED That the Cabinet Member for Property and Infrastructure and the Cabinet Member for Finance agree to the following capital release request of £25k from the Property Works Programme (PWP) Capital Budget 2021/2022; Miscellaneous Programme for the works to relocate the access to the substation on Whiteheath Avenue, Ruislip.
Reason for decision	To proceed with the approved disposal of the site adjacent to the Whiteheath Junior School, the access route to the substation to the rear of the site will need to be moved to a new position. Approving the release of funds will enable these works to proceed.

Alternative options considered and rejected	Ensuring these works are carried out enables access to UK Power Network to the substation as required to maintain electrical supply to the local area.
