DECISION	APPROVED That the Cabinet Member for Families, Education and Wellbeing agrees to the Variation of Instrument of Government for Bourne Primary School.
Reason for decision	The Bourne Primary School Governing Body had expressed interest in increasing their membership by two governors; by increasing the number of co-opted governors from two to five and reducing the number of parent governors from three to two. The governors agreed that their Instrument of Governance requires more flexibility to recruit governors with specific skills such as finance, HR and curriculum.
Alternative options considered and rejected	The Cabinet Member could have declined to approve the variation.
