DECISION	APPROVED That the Cabinet Member for Families, Education and Wellbeing agrees to the Variation of Instrument of Government for the Governing Body of Lady Banks Schools.
Reason for decision	<p>The Governing Body of Lady Banks Schools (amalgamated school as of September 2021) would like to decrease their membership by four governors and change the name of the governing body to the Governing Body of Lady Banks Primary School to reflect the successful amalgamation of both Infant and Junior Schools. <i>They currently have 18 members; the proposed change would decrease this number to 14 members in total.</i></p> <p>The Council's School Governance Team has confirmed that the Governing Body of Lady Banks Schools have submitted the correct documentation.</p>
