<b>DECISION</b>	<b>APPROVED</b>  That the Cabinet Member for Finance and the Cabinet Member for Property and Infrastructure:  <ol style="list-style-type: none"><li>1. accept the tender and approve the award of contract for Phase 17 electrical fire safety upgrades within 395 of the Council's general needs housing stock to PFL Electrical Services Ltd at a cost of £284,203.15; and</li><li>2. agree to the capital release requests of £327k from the Fire Safety Workstream within the Housing Revenue Account Works to Stock Programme 2021/22 capital budget for the installation of Phase 17 electrical fire safety upgrade within 395 of the Council's general needs housing stock (Appendix A).</li></ol>
<b>Reason for decision</b>	Recent changes to BS5839-6:2019 now require general needs rented housing properties to have a minimum level of LD2 Fire Detection, which requires interlinked detection devices to be fitted in all kitchens, principal habitable rooms and escape

	routes. Officers have implemented a planned upgrade of electrical consumer units with all general needs housing stock.
