<b>DECISION</b>	<b>APPROVED</b>  That the Cabinet Member for Property and Infrastructure and the Cabinet Member for Finance, agreed to the following capital release request of £17k from the Civic Centre Works Programme (CCWP) Capital Budget 2021/2022; Electrical Programme for the installation of electric vehicle charging points in the basement car park.
<b>Reason for decision</b>	As part of its Carbon Reduction Commitment, the Council is seeking to reduce its carbon footprint by replacing our existing fleet of pool cars with electric or hybrid vehicles. To enable these vehicles to be used, an additional three charging points are required to augment the existing charging points in the Civic Centre, bringing capacity to 6 fast charging points.
