| DECISION | APPROVED That the Cabinet Member for Finance and the Cabinet Member for Property and infrastructure agreed to the capital release request of £28k from the Housing Revenue Account Works to Stock Programme 2021/22 Fire Safety Workstream capital budget for the installation of replacement fire rated electrical intake cupboard door sets in Rabbs Mill House, Uxbridge. |
| Reason for decision | Fire risk assessments (FRAs) were undertaken by Frankham RMS Consultancy. The report recommended that all electrical intake cupboards do not meet with the current fire regulations and would not provide appropriate protection in the event of a fire. Following these recommendations, we are required to upgrade all the electrical intake cupboard door sets to be fire rated. Replacing the electrical intake cupboard door sets will ensure that we are compliant with fire safety regulations. |
