<b>DECISION</b>	<b>APPROVED</b>  That the Cabinet Member for Public Safety and Transport:  <ol style="list-style-type: none"><li>1. Noted the objections received during the statutory consultation for the proposed removal of a section of permit holder parking place opposite Nos. 171 and 173 Woodland Avenue, Eastcote.</li><li>2. Approved for the section of parking place opposite Nos. 171 and 173 Woodland Avenue, Eastcote to be removed and replaced with sections of 'Monday to Saturday 9am to 5pm' waiting restrictions as proposed and indicated on Appendix A.</li></ol>
<b>Reason for decision</b>	To allow clear vehicular access in front of the new vehicle crossing being constructed on Woodlands Avenue for the new development near the junction with Telcote Way. Following investigation no further parking could be created to offset the loss of parking as a result of the changes.
