	APPROVED That the Cabinet Member for Families, Education and Wellbeing agrees to the Variation of Instrument of Government for Warrender Primary School.
Reason for decision	The Warrender Primary School Governing Body would like to change their membership of governors, reducing the number of parent governors to 2 and increasing the number of co-opted governors to 7. This will reflect the needs of the school, as it will allow a wider skillset to be present on the governing body. The total number of governors remains at 12.
