	APPROVED That the Cabinet Member for Finance and the Cabinet Member for Property and Infrastructure agree to: 1. a contract variation with Logan Construction (South East) Ltd for £478k for additional works to the extension at the Uxbridge Mortuary; and 2. the capital release request of £498k from the general capital contingency 2021-26 budget for the funding of the additional works to the extension at the Uxbridge Mortuary.
Reason for decision	Approving this release will allow for the completion of the necessary extension and reconfiguration of the existing facilities on site required at Uxbridge Mortuary, to increase capacity in terms of storage, post-mortems and the development of a training centre on site.
Alternative options considered and rejected	The daily operation of the Uxbridge Mortuary is limited, due to the current capacity and equipment. Alternatives, such as the hire of temporary storage units, is no longer an efficient way of operating. Therefore, these works are required to ensure the
