	APPROVED That the Cabinet Member for Finance and the Cabinet Member for Property and infrastructure agreed to the capital release request of £20k from the Housing Revenue Account Works to Stock Programme 2021/22 Playground Replacement Workstream capital budget for the HRA contribution towards the Addison Way Toddler Playground Refurbishment.
Reason for decision	The decision to refurbish the Addison Way Toddler Playground will create a safer and more inviting play area for families with young children to use.
Alternative options considered and rejected	Options for phasing the works or reducing the scope of the play area were considered however, given that the extent of the disrepair means that all existing play equipment needs to be replaced, this was not viable.
