	<b>APPROVED</b>  <b>1) That the Leader of the Council accepted the Transport for London Grant 2021/22 allocation of £53k for the Bridge Assessment and Strengthening Local Implementation Plan; and,</b>  <b>2) The Cabinet Member for Finance and Cabinet Member for Public Safety and Transport agreed to the capital release request of £53k from the Transport for London Grant 2021/22 Bridge Assessment and Strengthening programme budget to support the schemes outlined in the report.</b>
<b>Reason for decision</b>	The Council received a funding allocation through the Transport for London (TfL) - Bridge Assessment and Strengthening Programme for the financial year 2021/22. The proposal fully complied with and supported the intentions of the 2018 Mayor of London's Transport Strategy and the proposals set out in the Council's LIP3 which covers the period from 2019 to 2041. The decision will enable Hillingdon to sustain its past LIP

	performance which is critically important to secure future funding to the Borough.
