	Approved That the Cabinet Member for Finance and the Cabinet Member for Property and Infrastructure: 1) Accept the tender and approve the award of contract for phase four hardwired group living call system within three of the Council's Sheltered Housing Schemes to Oxygene Services Group Ltd at a cost of £133,491.18; 2) Approve the reallocation of £154k funding from the Warm, Safe, Dry work-stream within the Housing Revenue Account Works to Stock Programme 2021/22 capital budget for the upgrade of phase four hardwired group living call system within three of the Council's Sheltered Housing Schemes).

Reason for decision	<p>The project will provide tenants within Sheltered Housing with an enhanced and flexible Grouped Warden Call Facility, which will continue to work once telephone line digitisation has been completed and will increase tenants' satisfaction within their homes within Sheltered Housing dwellings.</p> <p>In addition, the works will allow for the interconnection of existing Fire Detection Systems within dwellings to further enhance the fire safety within these properties.</p>
