	<b>Approved</b>  That the Cabinet Member for Finance and the Cabinet Member for Property and Infrastructure accept the tender from Orbis Protect Limited for the provision of an emergency property protection service for securing doors and windows to the London Borough of Hillingdon for three years + a two-year extension period from 01 of April 2022 to 31 of March 2027 and at the value of £150k.
<b>Reason for decision</b>	There is no formal term contract currently in place for this service with instructions to contractors provided on an ad hoc basis. The proposed arrangement will provide increased commercial and contractual rigor in the operational delivery of services.
<b>Alternative options considered and rejected</b>	There are no alternative options, Orbis Protect Ltd currently provide a service on an ad-hoc basis.
