Reason for decision	The proposed contract is to undertake the planned renewal of single glazed windows in 36 number properties, detailed in Appendix C of the confidential report.  This is Phase 8 of a phased programme of window renewals which is aimed at quickly dealing with replacements and enabling the effective management of smaller work packages
