	Approved That the Cabinet Member for Property, Highways & Transport and the Cabinet Member for Finance agreed to the capital release request of £4,368,936 for resurfacing 14 carriageways and 11 footways to be funded from the Highways Structural Works 2022/23 capital budget.
Reason for decision	<p>The decision made will enable the release of resources in order to progress the Highways programme for carriageway schemes informally approved by the Cabinet Member for Property, Highways and Transport and detailed in Appendix A to the report.</p> <p>The list contains schemes to limit the deterioration of the fabric of the Borough's highways asset that may have resulted in serious failure of roads, footways, verges, highway drainage and street furniture and improve the serviceability of the highway</p>

	network (for example the visual appearance, the ride quality and structural integrity of the roads and pavements).
Alternative options considered and rejected	No alternatives were considered due to the level of deterioration as delaying these schemes would have placed additional pressure on the Council's financial resources if permanent repairs were not implemented in a timely manner.
