Considered the objections received from the statutory consultation for the proposed 'At Any Time' waiting restrictions on Morris Avenue at its junction with Worrall Lane, Uxbridge; and  2. Did <u>not</u> approve the introduction of the proposed 'At Any Time' waiting restrictions on the junction of Morris Avenue and Worrall Lane.
