	<b>Approved</b>  That the Cabinet Member for Finance and the Cabinet Member for Property, Highways & Transport agreed to the capital release requests of £26k from the School Conditions Building Programme 2022/23 - 2026/27 budget for the funding of the upgrade to the lightning protection system at Ruislip Gardens Primary School.
<b>Reason for decision</b>	An upgrade of the current lightning protection system at Ruislip Gardens Primary school is required to meet BS EN 62305:2011/12 (Level 4) standards.
<b>Alternative options considered and rejected</b>	Not carrying out the works would leave the school vulnerable to a health and safety risk.
