	Approved That the Cabinet Member for Finance and the Cabinet Member for Property, Highways & Transport agreed to the capital release requests of £484k for electrical fire safety remedials and upgrades to the London Borough of Hillingdon housing stock, contained within the approved term contract for Electrical Testing, Repairs and Upgrades.
