	Approved That the Cabinet Member for Children, Families and Education agreed to the Variation of Instrument of Government for Ruislip Gardens Primary School as set out in the report.
Reason for decision	The Ruislip Gardens Primary School Governing Body wished to change their membership of governors, reducing the number of parent governors by 1 and increasing the number of co-opted governors by 1. This would reflect the needs of the school, as it would allow a wider skillset to be present on the governing body. The total number of governors remains at 14.
Alternative options considered and rejected	The Cabinet Member could have declined to approve the Variation or requested more information about it.
