### Decision made

<b>Cabinet Members making the decision</b>	Councillor Jonathan Bianco – Cabinet Member for Property, Highways & Transport Councillor Martin Goddard – Cabinet Member for Finance
	<b>Approved</b> That the Cabinet Member for Finance and Cabinet Member for Property, Highways and Transport:  1) Approved the allocation of £36,127 from the s106 contributions held at PT/163/40I; PT/219/429A and PT/221/429C to be used towards the enhancement of the Legible London signage in Hayes Town Centre; and,  2) Approved the capital release requesting £36,127 towards the scheme, as outlined in Appendix A to the report.
<b>Reason for decision</b>	In accordance with the Council's Constitution, the allocation of Section 106 (s106) and Section 278 (s278) funds is required to be formally approved by the Cabinet Member for Finance on a case-by-case basis – and any capital release, in conjunction with the relevant Cabinet portfolio holder. The report requested the approval for the s106 funds held at case references detailed in the report to be committed as outlined in the report.
<b>Alternative options considered and rejected</b>	The Cabinet Members could have agreed to fund the scheme and/or suggest alternative projects to which funds could be allocated within the terms of the relevant legal agreements. If the s106 funds were not allocated to an appropriate scheme, the unspent funds may need to be refunded.
