<b>Cabinet Members making the decision</b>	Councillor Martin Goddard – Cabinet Member for Finance Councillor Jonathan Bianco – Cabinet Member for Property, Highways and Transport
<b>Decision</b>	<b>Approved</b>  That the Cabinet Member for Finance and the Cabinet Member for Property, Highways and Transport:  1) Accepted the tender and approve the award of contract for the Planned Kitchen and Bathroom Renewals Phase 16 to PFL Electrical Ltd at a cost of £394,650; and,  2) Agreed to the capital release requests of £455k inclusive of contingencies and fees from the Kitchens and Bathrooms Renewals work-stream within the Housing Revenue Account Works to Stock programme 2023/24 budget for the Planned Kitchen and Bathroom Renewals Phase 16.
<b>Reason for decision</b>	The proposed contract was to undertake the planned renewal of 40 kitchens and 40 bathrooms under Phase 16 of the programme, detailed in Appendix B to the report. A number of kitchens and bathrooms were in a poor condition and at the end of their useful life.
<b>Alternative options considered and rejected</b>	None considered. The chosen approach will enable more specialist contractors to deliver installations at lower costs.
