	That the Cabinet Member for Finance, in conjunction with the Cabinet Member for Residents' Services: 1) Approved the allocation of £144,814 from the S106 contribution held by the Council at E/155/429F, towards recreational improvements to Cranford Park, as part of the Cranford Park Project; 2) Approved the allocation of £58,312 from the S106 contribution held at E/158/580A, towards recreational improvements to Cranford Park, as part of the Cranford Park Project; and, 3) Approved the allocation of £1,000 from the S106 contribution held by the Council at E/156/568C towards the provision of signage at the Watersplash entrance to Cranford Park, as part of the Cranford Park Project.						
Reason for decision	In accordance with the Council's Constitution, the allocation of Section 106 (S106) and Section 278 (S278) funds is required to be formally approved by the Cabinet Member for Finance on a case-by-case basis – and any capital release, in conjunction with the relevant Cabinet portfolio holder.						

Alternative options considered and rejected	The Cabinet Member could have agreed to fund the scheme and/or suggest alternative projects to which funds could be allocated within the terms of the relevant legal agreements. If the S106 funds were not allocated to an appropriate scheme, the unspent funds may have needed to be refunded.
