	That the Cabinet Member for Property, Highways and Transport:
	 Considered the objections and letters of support to the installation of a 20mph zone on Glebe Avenue and Sussex Road, as detailed within the body of the report;
	2. In consideration of the benefit to the road safety of those travelling to and from the local schools and Ickenham Station, instructed officers to proceed with the implementation of the restriction as set out;
	 Reviewed the requests received from residents to include surrounding roads within the 20mph zone and asked officers to consider proposals and report back; and
	4. Instructed officers to review the impact of the restrictions at an appropriate time following implementation, and report back.
Reason for decision	The recommendations set out in this report allow for the scheme to be progressed to benefit road safety for those travelling to and from the large primary school in the area and Ickenham Station

	which offers step free access. The introduction of a 20mph will make access into and out of the new disabled car park safer for uses.
Alternative options considered and rejected	The Cabinet Member may decide not to proceed with the 20mph zone introduction as this time, however this may have an impact upon the delivery of the new car park at Ickenham Station.
