	Approved That the Cabinet Member for Property, Highways and Transport: <ol style="list-style-type: none">1. Noted the responses received to the informal consultation for a possible extension to the operating times of the existing waiting restrictions throughout The Greenway, Ickenham;2. Decided to take no further action to amend the existing restrictions in The Greenway, Ickenham at this present time due to the response from residents and views indicated by the local Ward Councillors; and3. Instructed officers to advise Parking Services colleagues to carry out regular targeted enforcement of the existing restrictions on section of The Greenway, Ickenham near to shops where significant non-compliance had been noted by residents.
Reason for decision	The decision reflects the views of the local Ward Councillors and the response received to the informal consultation where the majority of residents and nearby businesses who responded have indicated a preference of no change.

Alternative options considered and rejected	The consultation with residents of The Greenway, Ickenham offered the option of extended operating times for all of the existing waiting restrictions or for no changes to be made to the current parking arrangements.
