Considered the objections received from the statutory consultation for the proposed 'At Any Time' waiting restrictions on the junction of Manningtree Road and Braintree Road, Ruislip; and</li><li>2. Approved the introduction of the proposed 'At Any Time' waiting restrictions on the junction of Manningtree Road and Braintree Road, Ruislip, as shown at Appendix B.</li></ol>
