	Approved  That the Cabinet Member for Finance and the Cabinet Member for Residents' Services agreed to the project and the capital release request of £405k from the Town Centre & Shopping Parades Initiative programme budget for the funding of the public realm improvements at Mulberry Parade.
Reason for decision	The proposed landscaping enhancements with extensive low-level planting and a new tree will not only be aesthetically pleasing but will also contribute towards air quality and improved health benefits for people who live, work and shop along this section of Mulberry Parade.  The project will be furthering the Council's vision to become the greenest London Borough, to protect and enhance the environment, and to provide a brighter prospect for future generations.
Alternative options considered and rejected	The Cabinet Members could have decided not to accept the recommendation. This would have meant that the proposed works could not go ahead as planned and the regeneration of Mulberry Parade would not be achieved.
