#### **Decision made**

Cabinet Members making the decision	The Leader of the Council, in conjunction with the Cabinet Member for Finance and the Cabinet Member for Property, Highways and Transport
	That the Leader of the Council, and on behalf of the Cabinet Member for Property, Highways and Transport and the Cabinet Member for Finance, approved:  1. The allocation and reallocation of £524k for resurfacing carriageways;  2. The capital release request of £354k and the reallocation of £170k of previously released funding from the 2023/24 Highways Structural Programme budget for the resurfacing of carriageways; and  3. The reserve list of schemes to drawdown from should additional funding become available from underspends on completed schemes.
Reason for decision	On 04 October 2023, the Government announced £8.3 billion of additional highways maintenance funding over the period 2023 to 2024 of which Hillingdon has been allocated £354k.

Executive Decision Notice - 21 February 2024

This funding, received only recently, is in addition to local transport funding from the last Spending Review and in addition to what local authorities were expecting in future. Officers recommend that Cabinet Members accept and release this grant to support the Highways Structural Works 2023/24 programme.

Appendix A of the report contains a list of resurfacing schemes that are to be funded from Department for Transport (DfT) grant funding and reallocation of previously released funds to improve road surface condition and limit deterioration of the fabric of the Borough's highways asset, which could have resulted in serious failure of roads, footways, verges, highway drainage, and street furniture, as well as to improve the serviceability of the highway network (for example, the visual appearance, ride quality, and structural integrity of the roads and pavements).

Should additional savings be made within the programme after the approved schemes are completed, the reserve list schemes will be prioritised for resurfacing, as detailed in Appendix B of the report.

# Alternative options considered and rejected

There are no alternatives due to the level of deterioration as delaying these schemes would place additional pressure on the Council's financial resources if permanent repairs were not implemented in a timely manner.

In many instances, any delay of this programme may also have safety implications with a possible consequent impact on the Public Liability Insurance budget.
