	That the Cabinet Members:
	1. Approve forward phasing from the HRA Unallocated Acquisitions and Development Budget 2024-25 of £3,131k and that this amount if then vired to the Housing Revenue Account (HRA) Acquisitions 2023/24 Normal buyback budget, to fund additional buybacks above the acquisition cap.
	2. Agree to the purchase and repair of 13 properties outlined in the separate Appendix pack sent with the release
	3. Agree to the following capital release requests of £3,131k from the Housing Revenue Account (HRA) Acquisitions 2023/24 Normal buyback budget for the funding of the purchase and repair of six properties, as detailed in the report (Appendix A).
	4. Agree to the following capital release request totalling £3,617k from the HRA Acquisitions - GLA and DLUHC Grant Funded Schemes Budget 2023/24 as follows:

Alternative options	Cabinet Member for Property, Highways and Transport.  The alternative option is to not buy back the properties, with the
considered and rejected	vendors selling them privately on the open market. This would not assist the Council in increasing the supply of social housing in the Borough, in meeting the one-for-one replacement commitment, or in utilising time-limited RTB receipts. Alternatively, the Council could offer lower purchase prices to the vendors. However, the Council is in competition with private buyers for these properties, with no leverage to compel the vendors to accept below-market prices, and the prices offered in this report have already been accepted by the vendors.
