Decision	Approved That the Cabinet Member for Finance and the Cabinet Member for Property, Highways and Transport: 1) Accepted the tender and approved the award of contract for the Planned Kitchen and Bathroom Renewals Phase 28 to PFL Limited at a cost of £378,397.14; and 2) Agreed to the capital release request of £435k inclusive of contingencies and fees from the Kitchens and Bathrooms Renewals workstream within the Housing Revenue Account Works to Stock programme 2024/25 budget for the Planned Kitchen and Bathroom Renewals Phase 28.
Reason for decision	The proposed contract is to undertake the planned renewal of 40 kitchens and 40 bathrooms (8 with separate WCs) under Phase 28 of the programme, as detailed in Appendix B of the confidential report. A number of kitchens and bathrooms are in a poor condition and at the end of their useful life. This is Phase 28 of a phased programme of kitchen and bathroom renewals that is aimed at quickly dealing with replacements, enabling the effective management of smaller

	work packages and reducing costs using smaller, more specialist installation companies.
Alternative options considered and rejected	Alternative options were not considered as the Council is moving away from the larger type of delivery contracts. This approach will enable more specialist contractors to deliver installations at lower costs.
