### Decision made

<b>Cabinet Members making the decision</b>	Councillor Martin Goddard - Cabinet Member for Finance Councillor Jonathan Bianco - Cabinet Member for Property, Highways and Transport
<b>Decision</b>	<b>Approved</b>  That the Cabinet Member for Finance and Cabinet Member for Property, Highways and Transport:  1) Approved the allocation of £53,185 from six S106 air quality contributions held by the Council, to be spent towards the implementation of Phase 1 of Hillingdon's Electric Vehicle Charging Infrastructure Programme.  2) Approved the capital release requesting £53,185 to be used towards the scheme, as outlined in Appendix A to the report.
<b>Reason for decision</b>	In accordance with the Council's Constitution, the allocation of Section 106 (S106) and Section 278 (S278) funds is required to be formally approved by the Cabinet Member for Finance on a case-by-case basis – and any capital release, in conjunction with the relevant Cabinet portfolio holder. This report requests the approval for the S106 funds held at case references detailed in this report to be committed as outlined in this report.
<b>Alternative options considered and rejected</b>	The Cabinet Members may agree to fund the scheme and / or suggest alternative projects to which funds could be allocated within the terms of the relevant legal agreements. If the S106
