## Decision made

<b>Cabinet Members making the decision</b>	Councillor Steve Tuckwell – Cabinet Member for Planning, Housing & Growth Councillor Martin Goddard - Cabinet Member for Finance and Transformation
<b>Decision</b>	<b>Approved</b>  That the Cabinet Member for Planning, Housing & Growth and the Cabinet Member for Finance & Transformation agreed to the capital release of £517,335 for resurfacing a section of Harvil Road, Ickenham and South Harefield from the 2024/25 Highways Structural Programme budget.
<b>Reason for decision</b>	The report sought funds from HS2 to resurface Harvil Road. A study on HS2 traffic deterioration led to a bid, resulting in HS2 contributing £517,335. The remaining cost would be covered by the 2024/25 Highways Structural Programme. Approved by the Cabinet Member, the project aimed to improve road integrity and appearance
<b>Alternative options considered and rejected</b>	Delaying the scheme due to severe deterioration could close Harvil Road and return HS2 funds, straining the Council's finances. Timely repairs are crucial to avoid safety concerns and potential impacts on the Public Liability Insurance budget.
