<b>Decision</b>	<b>Approved</b>  That the Cabinet Member for Finance & Transformation:  <ol style="list-style-type: none"><li>1. Approved that a total of £210,000 from the s106 air quality contributions held by the Council is allocated and used towards the provision of expert evaluation to deliver the implementation of the Council's Air Quality Action Plan. This is in accordance with MTFF proposals.</li><li>2. Approved that a total of £150,000 from the S106 carbon off set contributions held by the Council is allocated and used towards project management costs to support the delivery of the Council's S106 Carbon offset fund. This is in accordance with MTFF proposals.</li></ol>
