Once a formal Notice is served on the Council under the Leasehold Reform, Housing and Urban Development Act 1993, the Council is bound to comply with the provisions and timescales in the Act. The Council will need to negotiate the premium to be paid by the leaseholder for an extension of the term for a further 90 years in each case.2. Once the Counter Notice is served by the Council, this triggers the negotiations for the premium payable for the lease extension |
