<b>Cabinet Members making the decision</b>	Councillor Goddard - Cabinet Member for Finance & Transformation
<b>Decision</b>	<b>Approved</b> That the Cabinet Member for Finance and Transformation agreed the allocation and spend of s106 construction training contributions as follows:  That a total of £114,000 (£57,000 per annum for two years 24/25 & 25/26) is allocated towards the Regeneration and Economic Development Team Core Budget to support the coordination of construction training work placements in the Borough.
<b>Reason for decision</b>	In accordance with the Council Constitution, the allocation of Section 106 (S106) and Section 278 (S278) funds is required to be formally approved by the Cabinet Member for Finance & Transformation on a case-by-case basis.
<b>Alternative options considered and rejected</b>	Alternative options were set out in the report and considered. If S106 funding was not agreed for 2024/25 and 2025/26 there would be an overspend of £114,000 on this cost centre over the two years.
