<b>Decision</b>	<b>Approved</b>  That the Cabinet Member for Finance & Transformation, in consultation with the Cabinet Member for Planning, Housing & Growth, agreed to the release of £343,564 from the GLA's Good Growth Fund Grant for Hayes Town Centre for the projects outlined in the report for the 25/26 financial year.
<b>Reason for decision</b>	The recommendations enable the required release of capital funding from the Greater London Authority's (GLA) Good Growth Fund for the continuation of improvement works in Hayes Town Centre during the 2025/26 financial year. The capital release is necessary to enable officers to draw down and use the funds for planned public realm enhancements, activation of vacant commercial units, and community engagement initiatives, in line with the grant agreement.
