<b>Decision</b>	<b>Approved</b>  The Cabinet Member for Finance & Transformation, in consultation with the Cabinet Member for Planning, Housing & Growth:  <ol style="list-style-type: none"><li>1) Approved the allocation of £33,000 from the S106 contributions held at PT/279/594A to be used towards pedestrian accessibility improvements in Yiewsley/ West Drayton;</li><li>2) Approved the reallocation of £5,000 of previously released funds from the S106 contributions held at PT/167/382A to be used towards the above scheme; and</li><li>3) Approved the capital release requesting £33,000 towards the scheme, as outlined in Appendix A to this report.</li></ol>
<b>Reason for decision</b>	The recommendations ensure that external contributions were used effectively to deliver viable improvements benefiting local communities, in accordance with the terms of the legal agreements and to avoid potential repayment of unspent funds.
