### Decision made

<b>Cabinet Members making the decision</b>	Councillor Steve Tuckwell, Cabinet Member for Planning, Housing & Growth
<b>Decision</b>	<b>Agreed</b>  <b>The Cabinet Member for Planning, Housing &amp; Growth:</b>  <b>1) Noted the responses received to the formal consultation for the proposed installation of double yellow lines in Pynchester Close, Ickenham; and</b>  <b>2) Following discussion with the local Ward Councillors, decided that formal consultation be carried out on the revised proposals for shortened double yellow lines at the junction of Pynchester Close and Hoylake Crescent, Ickenham, as shown in the Report - Appendix C.</b>
<b>Reason for decision</b>	The recommendations were based on the majority of responses received from residents during the consultation, together with comments from the local Ward Councillors. The feedback indicated support for measures to improve safety at the junction of Pynchester Close and Hoylake Crescent.
<b>Alternative options considered and rejected</b>	The Council could have decided to install the double yellow lines as they were proposed or deferred the proposals altogether.
