<b>Cabinet Members making the decision</b>	Councillor Steve Tuckwell - Cabinet Member for Planning, Housing & Growth
<b>Decision</b>	<b>That the Cabinet Member for Planning, Housing &amp; Growth:</b>  1) <b>Noted the low response rate to the consultation of just 2.3%;</b>  2) <b>Considered that all responses reported were for the introduction of the proposed 7.5T weight limit in the area, and generally positive feedback had been received as detailed in the report; and</b>  3) <b>Due to the road safety and residential benefit of introducing the restriction, instructed officers to proceed with seeking HS2 funding for the implementation of the scheme.</b>
<b>Reason for decision</b>	The recommendations set out in this report allow for the scheme to be progressed to benefit road safety and to improve environmental conditions for the residents.
